ORDER

1. University wide paper read (1) above, invited applications for Continuation of Provisional Affiliation for the academic year 2024-25 from the colleges for the courses affiliated to the University.
2. In response to the same, Principal, KMCT Ayurveda Medical college, Kozhikkode, vide paper read (2) above submitted their application with necessary documents and remitted required fee.
3. Subsequently, University conducted an inspection at the college to assess the facilities available for conducting UG (BAMS) course with 60 seats and the inspection commission submitted its report vide paper read (3) above.
4. Vide paper read (4) above, scrutiny committee verified the inspection reports and pointed out deficiencies in IP/OP patients ratio and faculty position at the college and the same were communicated vide paper read (5) above. In response to the same, the principal submitted a compliance report vide paper read as (6) above.
5. Vide paper read (7) above, scrutiny committee examined the compliance report and found that the deficiencies pointed out in previous inspection were not rectified and thereby scrutiny committee did not recommend for Continuation of Provisional Affiliation to the college for the academic year 2024-25.



6. Subsequently, a surprise inspection was conducted at the college to cross check the above mentioned deficiencies and the report was received at the University vide paper read (8) above.

7. Scrutiny committee verified the re-inspection report vide paper read as (9) above and found satisfactory. Thereby, scrutiny committee recommended to grant Continuation of Provisional Affiliation to KMCT Ayurveda Medical college, Kozhikkode for conducting UG (BAMS) with 60 seats for the academic year 2024-25.

8. The recommendation of the scrutiny committee was placed in the Governing Council meeting and vide decision read (10) above, the Governing Council resolved to grant Continuation of Provisional Affiliation to KMCT Ayurveda Medical college, Kozhikkode for conducting UG (BAMS) courses with 60 seats for the academic year 2024-25, subject to the receipt of Letter of Permission from the Ministry of AYUSH.

9. Vide paper read (11) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India has granted conditional permission to KMCT Ayurveda Medical college, Kozhikkode for an intake capacity with 60 seats for the academic session 2024-25 under section 28 of the NCISM Act 2020.

10. As per the paper read (12) above, Governing Council had decided that an affidavit incorporating a clause to the effect that " if GST is imposed on the affiliation and other services by the authorities concerned, such GST and other dues including penalty if any will have to be borne by the affiliated institutions" and the affidavit shall be submitted to the university by the affiliated colleges. The Principal, KMCT Ayurveda Medical college, Kozhikkode has not submitted the aforesaid affidavit to the university so far.

11. In the circumstances, orders are hereby issued granting **Conditional Continuation of Provisional Affiliation** to KMCT Ayurveda Medical college, Kozhikkode for conducting BAMS course for an intake capacity with 60 seats for the academic year 2024-25. **The Conditional Continuation of Provisional Affiliation now granted will be confirmed only on submission of an affidavit by the college with respect to levying of GST in the prescribed format within 3 months of the date of this order.**

12. As per the clause 2(5)(ix)(16) of the amendment of the 1st Statute on the matter of Affiliation of Colleges, ' **if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfilment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation cease automatically. If the conditions are fulfilled, the Governing Council shall have the power to confirm the affiliation at the end of the period.**'

13. The college shall strictly adhere to the following conditions detailed below :-

i) **The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG course (60 seats) in Ayurveda during 2024-25 vide letter read (11) above.**

ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

v) The College should remit balance annual administration fee fixed for UG course for the academic year 2024-25, if applicable.

vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.


